## **TOGETHER WE LIVE AS ONE**

In the wee hours of the morning, six-year-old Noah took his three-year-old sister to their nice neighbor to ask for help. Earlier in the day, in his first-grade class, a police officer talked about what to do if you do not feel safe and how to find safe adults to help. Noah and his sister left because their parents were physically fighting amidst a drug-induced hysteria. Unfortunately, Noah's parents had been abusing drugs for some time, and this was not the first time they were at home without a responsible parent to care for them. The neighbor showed kindness and reassured the children they were safe. The police and social worker arrived; took them to a warm foster home with food and clean clothing where they slept

peacefully side by side. The next day at the

Lakeshore Regional Child Advocacy Center, they both received a special medical exam with the child abuse pediatrician. Noah also met with the forensic interviewer and in a recorded interview was able to say aloud all the things that had happened in his home. This information was critical to keep Noah and his little sister safe, hold their parents accountable, and help put a plan together so that everyone in the family can heal and thrive.

One day, Adam told his teacher how his older cousin was playing a new game with him while he was babysitting for him. It became clear that this family member had perpetrated sexual assault. Adam and his family were referred to the Sexual Assault Community Advocate for counseling. Through counseling, the help of supportive parents, and a protective teacher, Adam began to come out of his shell, heal and feel more confident. He still knew he had been a victim but stopped blaming himself for the chaos that his family endured.



# A SPOTLIGHT ON HARDSHIP - ALICE

**ALICE** (Asset Limited, Income Constrained, Employed) describes households that earn income above the Federal Poverty Level (FPL), but below the basic cost of living. They struggle to afford essential needs of housing, food, childcare, health care, transportation, and technology. They are working and paying taxes, but not earning enough to be financially stable.

In Ozaukee County, 30% of residents are having difficulties with affording these necessities. In 2022 over 11,902 households in Ozaukee County were below the ALICE threshold. In 2022, household costs in Ozaukee County were well above the Federal Poverty Level of \$13,590 for a single adult and \$27,750 for a family of four.

#### **HELPING PEOPLE REALIZE THEIR FULL POTENTIAL**

- Adult Literacy Center of Ozaukee provides individualized educational services for adult learners to improve academic and life skills.
- Ozaukee Jail Literacy provides educational opportunities to incarcerated adults at the Ozaukee County Jail which helps reduce recidivism and increases the success of someone transitioning back into the community.
- Big Brothers Big Sisters creates and supports one-to-one mentoring relationship that ignites the power and promise of our youth.
- Ozaukee Family Services provides parents and caregivers with information and support to promote the healthy growth and development of children and to strengthen family relationships. OFS also provides affordable counseling for children, teens, adults, and seniors who are under-insured.

#### **CREATING A STRONGER FINANCIAL FUTURE**

- Advocates Homeless Prevention Program provides one-time yearly
  assistance to those working families or individuals that suffered financial
  hardship and are faced with an eviction. Funded by UWNO dollars and
  administered by Advocates of Ozaukee.
- Family Sharing of Ozaukee helps alleviate hunger with dignity and compassion through the Food Pantry, Mobile Food Pantry and Senior Home Delivery, ensuring access to nutritious meals for those struggling to make ends meet.
- Portal Inc. Community Connections & Employment Skills Program is
  designed to mentor people with significant disabilities/barriers to enrich
  work related skills and secure and maintain successful community
  employment.

#### IMPROVING HEALTH & WELL-BEING FOR ALL

- Nami a family-based organization whose purposes are to provide advocacy, education, support, awareness and understanding of the issues affecting persons with mental illnesses.
- Advocates Children's Program provides prevention, intervention and coping services for children and teens who have been affected by domestic violence or abuse.
- Balance Inc. provides services that promote mental health through socialization, community activities and life-enriching activities. In 2023, UWNO helped fund their art therapy program, helping adults with disabilities to improve their cognitive and emotional skills.
- Community Services Navigator connects the most vulnerable and atrisk residents quickly and comprehensively to needed services including medical providers, mental health services, substance treatment centers, housing, and other basic needs.
- Interfaith Caregivers of Ozaukee County enables seniors and individuals with disabilities to remain independent in their homes by providing critical transportation services.
- Lakeshore Regional Child Advocacy Center promotes collaborative intervention for children and families whose lives were impacted by abuse, neglect, and family violence. The Center equips a team of professionals with the skillset to identify abuse, intervene for children's safety, advocate for justice, and build resiliency.
- Sirona Recovery first and only established sober house in Ozaukee
  County serving men 18+. Provides structure and accountability needed
  for participants to gain daily living skills that will help them transition to
  independent living and a sober lifestyle in the community.




